## INSTRUCTIONS TO THE TENDERERS

The Tender shall be submitted in accordance with these instructions and any tender not confirming the instructions as under is liable to be rejected. These instructions shall form the part of the tender and contract.

1. For Online Bid Submission, as per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)). The bidders are required to submit soft copies of their bids electronically on the CPP Portal using valid Digital Signature Certificates.

More information useful for submitting online bids on the CPP Portal may be obtained at [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app).

2. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
3. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF formats. Bid documents may be scanned with 100 dpi with black and white option.
4. The Technical Bids will be opened on **25.03.2017 at 11:00 A.M.** The date & time for opening of Financial Bids will be notified on the portal. The bidders may regularly check the portal regarding the date of opening of financial bid.
5. The work shall be in compliance to the specifications mentioned in Annexure - I of the tender and shall be of the latest technology, best quality and high standards.
6. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any Tenderer stipulates any condition of his own, such conditional tender is liable to be rejected.
7. Director, ICAR-NRCP, reserves the right to reject any tender/bid wholly or partly without assigning any reason.
8. The Technical Committee constituted by the Director, ICAR-NRCP, Solapur shall have the right to verify the particulars furnished by the bidder independently.
9. All the tender documents & Price Bid to be uploaded as per this tender are to be digitally signed by the bidder.
10. **Tender Cost:** The bidder should submit a demand draft of Rs. 500/- (Rupees Five hundred only) towards non-refundable tender fee, drawn in favour of "ICAR Unit: NRC on Pomegranate" payable at Solapur in a sealed envelope super-scribed as "Tender fee for Hiring of Machines and NIT No. ICAR-NRCP/ Open Tender/36/Hiring of Machines/16-17 on or before last date & time of submission of bids. In the absence of tender cost, the tender will not be accepted.

11. **Earnest Money Deposit (EMD): An amount of Rs. 5000/- (Rs. Five thousand only)** in the form of Demand Draft drawn in favour of “ICAR Unit: NRC on Pomegranate” payable at Solapur This EMD should be submitted in sealed envelope super-scribed as “EMD for RC for Fertilizer and NIT No. **ICAR-NRCP/Open Tender/36/Hiring of Machines/16-17**. Failure to deposit Earnest Money will lead to rejection of tender. In the event of the awardee bidder backing out, EMD of that bidder will be forfeited. The EMD of the accepted Tender will be refunded only after on receipt of Contract Form and Performance Security of Rs.25,000/- (Rs. Twenty five thousand only) in the form of Demand Draft drawn in favour of “ICAR Unit: NRC on Pomegranate” payable at Solapur.

12. **Validity:** The bid should be valid for acceptance up to a period of 180 Days. The Bidders should be ready to extend the validity, if required without any additional financial implications

13. The machinery will be hired for as and when required by this Centre and will be informed in advance.

14. The machinery should be road worthy condition and trouble free. If the machinery is break down on the way/during operation work, machinery should be provided as early as possible in its place. The machinery offered shall be the latest model as determined by the Invoice.

15. Hire charges shall be paid within one month’s time against the pre-receipted bill in duplicate submitted in the name of Director, ICAR-NRCP, Solapur after completion of the awarded work, work done satisfactory certificate by the concerned official/indenter and approval of the same by the Director, ICAR-NRCP, Solapur.

16. The **Income Tax on prevailing rate** will be deducted from the bill amount as per the provision of TDS.

17. **Terms of Rate Contract:** The term of the contract will be for twelve months renewable after one year based on the satisfactory performance. The Supplier will have to sign the contract agreement soon after receipt of acceptance of their offer. The contract shall be effective only after the signing of contract agreement.

18. Responsibility of labours, drivers etc. and their insurance, machinery insurance and any untoward incidents/situations while working lies with the Contractor.
