## INSTRUCTIONS TO THE TENDERERS

The Tender shall be submitted in accordance with these instructions and any tender not confirming the instructions as under is liable to be rejected. These instructions shall form the part of the tender and contract.

1. For Online Bid Submission, as per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal (URL:<http://eprocure.gov.in/eprocure/app>). The bidders are required to submit soft copies of their bids electronically on the CPP Portal using valid Digital Signature Certificates. More information useful for submitting online bids on the CPP Portal may be obtained at [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app).
2. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:<http://eprocure.gov.in/eprocure/app>) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
3. The intending Tenderer, in case of Prime Equipment/item Manufacturers shall upload a self-declaration on their letter-head as PDF file in Cover-I of e-tender, along with the tender documents, confirming that they are regular in manufacturing, supplying, installing, testing & commissioning of the similar equipment/item.
4. The intending Tenderer, in case of Authorized Distributor/ Authorised Dealer shall possess valid authorized Distributorship/Dealership license from Original Equipment Manufacturers. The tenderer shall enclose the copy of the same as PDF file in Cover-I of the e-tender while submitting the tender.
5. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF formats. Bid documents may be scanned with 100 dpi with black and white option.
6. The Technical Bids will be opened on **16.03.2017 at 11:00 A.M.** The date & time for opening of Financial Bids will be notified on the portal. The bidders may regularly check the portal regarding the date of opening of financial bid.
7. The equipment/item shall be in compliance to the specifications mentioned in Annexure-I of the tender and shall be of the latest technology, best quality and high standards.
8. Any optional Accessories/Tooling, besides the standard equipment recommended for the better performance of the equipment, if offered, be provided with their full technical details including

their use and advantage in a separate sheet with the tender documents. Minimum one year warranty has to be provided for the equipment.

9. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any Tenderer stipulates any condition of his own, such conditional tender is liable to be rejected.
10. Director, ICAR-NRCP, reserves the right to reject any tender/bid wholly or partly without assigning any reason.
11. The Technical Committee constituted by the Director, ICAR-NRCP, Solapur shall have the right to verify the particulars furnished by the bidder independently.
12. All the tender documents & Price Bid to be uploaded as per this tender are to be digitally signed by the bidder.
13. **Tender Cost:** The bidder should submit a demand draft of Rs. 500/- (Rupees Five hundred only) towards non-refundable tender fee, drawn in favour of “ICAR Unit: NRC on Pomegranate” payable at Solapur in a sealed envelope super-scribed as “Tender fee for (Name of the Item) and NIT No. **ICAR-NRCP/Open Tender/34/Shade Net House/16-17**” on or before last date & time of submission of bids. In the absence of tender cost, the tender will not be accepted.
14. **Earnest Money Deposit (EMD): 2.5% /-** (Minimum of the cost quoted) in the form of Demand Draft drawn in favour of “ICAR Unit: NRC on Pomegranate” payable at Solapur This EMD should be submitted in sealed envelop super-scribed as “EMD for (Name of the Item) and NIT No. **ICAR-NRCP/Open Tender/34/Shade Net House/16-17**”. Failure to deposit Earnest Money will lead to rejection of tender. In the event of the awardee bidder backing out, EMD of that bidder will be forfeited.  
  
Note: Both (tender fee & EMD) envelopes should be placed in another sealed envelope and address to: “The Director, ICAR-National Research Centre on Pomegranate, NH-65, Solapur Pune Highway, Kegaon, Solapur 413 255” This envelop having tender fee & EMD should reach on or before last date & time of submission of bid.
15. **Validity:** The bid should be valid for acceptance up to a period of 180 Days. The Bidders should be ready to extend the validity, if required without any additional financial implications.
16. **Delivery:** Within 45 days from the Date of issue of award letter or as specified in the supply/work order. However, the Competent Authority will have the discretionary power to take appropriate decision.
17. **Prices:** The Prices quoted should be inclusive of all taxes or duties, packing, forwarding, freight, insurance, delivery and commissioning etc. at destination site (ICAR-NRCP, Solapur). ICAR-NRCP is registered with DSIR, Govt. of India and is exempted from Custom /Excise Duty. Exemption Certificate to this effect will be issued by ICAR-NRCP. Hence, Customs/Excise Duty exempted price should be quoted. Nothing extra shall be paid on any account.
18. **Mode of Payment:** Payment on bill basis after supply, satisfactory installation, commissioning and performance of the equipment/item at Solapur and after certification by our Scientists concerned.

19. **Installation, Training & Demonstration:** Bidders need to provide adequate training to the nominated persons of ICAR-NRCP at their cost. ICAR-NRCP will not bear any training expenditure. The supplier is required to done the installation and demonstration of the equipment/item within fifteen days of arrival of materials at the NRCP, Solapur site of installation, otherwise the penalty clause will be the same as per the supply of material.
20. **Liquidated damages Security:** In case the firm does not complete the supply within the laid down agreed delivery period as per contract, liquidated damages will be charged @ 2% of the contract value per month or part thereof. However, the Institute reserves the right to either further extend or cancel the contract after expiry of delivery date and recover the liquidated damages from the dues of the firm or by legal means.
21. **Insurance:** As applicable in the case of imported goods. For indigenous item, it will be responsibility of the supplier to supply the material in good condition on FOR basis without involving the risk of the purchaser.
22. **Dispute settlement:** The dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & court at Solapur. Sole arbitrator is appointed by the Secretary, ICAR, New Delhi. His decision will be final and binding to both parties.
23. **Guarantee/Warranty:** Minimum one year comprehensive on-site warranty required. Warranty Terms period will start from the date of installation of items. In case at installation stores/part of stores are found defective/damaged during or after delivery to consignee, the suppliers will replace or repair the store under warranty at consignee's location in India free of cost or if in any case it is required to send back to the foreign manufacturer, Bank Guarantee equivalent to the cost of equipment/item is required to be submitted before lifting the store. All expenses in this regard will be borne by the supplier.
24. **Performance Security:** The successful bidder will have to submit a Performance security of equivalent to **5%** of the Contract/Order value, having validity till expiry of the Warranty/Guarantee period in form of **DD in favour of "ICAR Unit: NRC on Pomegranate payable at Solapur**, Fixed Deposit Receipt from a Commercial Bank, Bank Guarantee from a Commercial bank in a acceptable form/prescribed proforma.
25. **Packing and Marking:** The packing and preservation of the supplied goods shall be airworthy/seaworthy/roadworthy (as the case may be) so that it may provide their safety during transit period. Each packing case shall have labels as follows:

## DETAILS OF ITEMS AND THEIR TECHNICAL SPECIFICATIONS

### 1) 50 % INSECT PROOF SHADE NET HOUSE

Nylon Net	40 mesh nylon net (insect proof), UV Stabilized and sulphur resistant for all the four sides upto 9 feet height.
Shade Net(Top)	50% HDPE Shade net, white color, UV Stabilized, Sulphur resistant for top.
Size	20 m width X 40 m length
Shape	Continuous slope from the topmost centre of shade net house (11.5-12.0 feet) to both the sides along the width of the polyhouse with two vents of approx. ½ feet on both sides.
Structure	Structure should be made of heavy MS pipe of about 1 ½” and 1” size for foundation and horizontal and vertical support, respectively with pipes after every 4 m width wise and about every 3.00 m lengthwise
Civil work	Cement + sand + jelly ratio must be 1:2:4, pipe should be 2 to 2 ½ feet below ground & pit size of at least 2.5ft D x 1ft W x 1ft L (0.75x0.3x0.3m)
Door	There should be a GI frame or MS frame door with locking facility
