Failure to deposit Earnest Money will lead to rejection of tender. In the event of the awardee bidder backing out, EMD of that bidder will be forfeited.
- 11. **Performance Security:** The EMD of the accepted Tender will be refunded only after on receipt of Contract Form and **Performance Security** of **Rs. 10,000/- (Rs. Ten thousand only)** in the form of Demand Draft drawn in favour of "ICAR Unit: NRC on Pomegranate" payable at Solapur.
- 12. **Rates**: Rates should be quoted including transport, loading, unloading, toll fee and LBT charges, if any.
- 13. The Rate Contract will be valid for one year and which may be extended for further period subject to satisfactory supply of quality Coco Peat.
- 14. **Validity:** The bid should be valid for acceptance up to a period of one year. The Bidders should be ready to extend the validity, if required without any additional financial implications.
